Conditions: All deliveries will be made within 24 hours from placement of the order, unless otherwise noted. If delivery cannot be made in that time frame, the school division has the right to place the order with another vendor. Any price differential will be paid by the vendor awarded the original bid acceptance. The delivery quantity will be subtracted from the gallon commitment. Any unused gallons from any school division may be purchased by another school division in the consortium at that school divisions contracted price.

The awarded vendor will provide invoices reflecting the contracted price only, not to include additional fees and/or taxes. No additional fees or taxes will be paid. Correct invoices with the bid price only will be requested, failure to provide such may cause termination of agreement.

The awarded vendor is required to provide monthly statements on company letterhead to the school division for reconciliation purposes. Failure to do so may cause termination of agreement.

The Charlotte County School Board reserves the right to accept or reject any and all bids in whole or in part. All bids must be submitted on the provided bid form.

An anti-gel/anti-icing additive shall be added between October 1st and March 1st. Cost of additives shall be included in fuel price. Fuel additive product information shall be provided with bid.

Bacon District Elem. School has a 3,000 gallon above ground tank. Eureka Elem. School has a 4,000 gallons above-ground tank. Each requires a tank wagon for delivery. Approximate annual usage is 9,000 at each school location. The Transportation Department Bus Garage tank is above ground with a maximum capacity of 9,500. A transport with a pump will be needed for delivery. Estimated annual bus garage usage is 52,000 gallons. The total annual usage for all locations listed is 70,000 gallons.
